Total Shop Solutions Six-Bay Giveaway

This is a trade promotion. By submitting entries, Participant agrees to accept and be bound by all the terms and conditions set forth in the Official Rules without any modification or reservation. Should Participant disagree with any or all of the terms and conditions below or desire not to be bound by them, or is not eligible, DO NOT PARTICIPATE in the Giveaway in any manner.

1. SPONSOR: Total Shop Solutions ("Sponsor"), 2801 80th St, Kenosha, WI, 53143.

2. NO PURCHASE NECESSARY. PURCHASE WILL NOT IMPROVE CHANCES OF WINNING.

3. GIVEAWAY PERIOD: All entries must be submitted between September 1, 2019 at 12:01 A.M. Central Time ("CT") and January 24, 2020 at 11:59:59 P.M. CT ("Giveaway Period"). The Sponsor's computer or server, as determined by Sponsor in its sole discretion, is the official time keeping device for the Giveaway.

4. ELIGIBILITY: The Giveaway is open and offered to purchasing employees of dealerships, automobile repair shops, and other businesses related to the automobile industry, who purchase any of the specified Qualifying Products (as defined below) during the Giveaway Period, and are legal residents of the 50 United States, the District of Columbia, and Puerto Rico, who are at least the age of majority in their state, or territory as of the date of entry ("Participant"). National accounts are not eligible. The "Qualifying Products" are: any new John Bean branded tire changer, wheel balancer, wheel aligner, or lift invoiced over \$2,500 United States Dollars ("USD"); any new Challenger-branded lift invoiced over \$2,500 USD that is registered on <http://www.challengerlifts.com/register-your-lift/>; any new Pro-Cut-branded lathe invoiced over \$2,500 USD; any new Hofmann branded tire changer, wheel balancer, wheel aligner or lift invoiced over \$2,500 USD; any new piece of Car-O-Liner-branded equipment invoiced over \$2,500 USD, and/or any one (1) year or longer new subscription to Mitchell1-branded product invoiced over \$150 USD per month. Qualifying Products does not include parts, accessories, or service, including installation. Employees, officers and directors of Sponsor, and its parent, each of its affiliates (as used in these Official Rules, "affiliate" means any legal entity controlling, controlled by, or under common control with a party), subsidiaries, independent representatives, franchisees, advertising, public relations, and Giveaway agencies, Webmasters/suppliers and members of the immediate family (spouse, children, siblings, parents), and persons living in the same household (whether or not related) of any of the above are ineligible.
